That by mentioning the name of BJP in the above press conference which you have made falsely and maliciously concerning the said organizations you have successfully lowered the reputation and created ill will against them in the minds of the persons of the society by leveling a very serious false allegation against the organizations. The above said utterance on your part is derogatory, defamatory and tantamount to the character assassination of the entire BJP.

You are called upon through this legal notice to tender written apology to my client and to entire BJP Organization within 3 days from the receipt of this legal notice, failing which, I have instruction to file civil and criminal complaint against you in that event you will be held responsible for all costs and charges incurred by my client.
